SUMMARY

These nine (9) minor TIP amendments have been recommended for Policy Board action by the Technical Advisory Committee per Section B3(c) of the Memorandum of Understanding between the South Jersey Transportation Planning Organization, New Jersey Department of Transportation, and New Jersey Transit Corporation dated August 16, 2006.

BACKGROUND
